CPD can't legally remove them. Officer Smith spoke with the city attorney to make sure he can't do anything. She needs to go through the due process system but Officer Smith has no control over that. One individual has a warrant out for his arrest so he can be arrested if seen. Residents have been alerted and CPD are actively looking for him. His name is Jeremy Blessing. He is male, Caucasian, and has tattoos. The man on the bicycle who was steeling things has also been sighted but we are still looking for him. The PNC thief has been arrested.
