**Development:** J. Hinderliter for D. Carey, Casto discussions still working on retail component, hope to have something more definitive for June public meeting.

840 Michigan Ave., preliminary building remains. Original developer ran out of funding, new developer. OLD proposal 47 residential, retail, 20 space parking variance approved by HWS. NEW proposal 62 bedroom residential project, asking for additional parking variances, no retail component. HWS stance: any previous approval now void and the developer needs to start over with the approval process. Initial rendering shared. Jonathan Barnes Architects representing the developer and want to move forward quickly. Mangia: exterior looks better on renderings.

3<sup>rd</sup> & Perry: 311 request submitted to city for intersection. Flagged as fixed by Wags (2017). Flagged recently as needing a remedy. City lacking funds. Traffic put in request for changes on Friday. Wags (Reidy) having conversations about changes to intersection (maybe stripes crosswalks and bump out to reduce traffic flow). Request raised median and type 2 ladder type crosswalk. Primarily car on car accidents at 3<sup>rd</sup> & Perry. Often people running Perry stop sign at fault.

Telephone poles heading S. on Perry obstruct sightlines at 3<sup>rd</sup>. Report to 311 and VisionZero.

**Parks:** B. Mangia. Need volunteers for 2020 to weed, clean and adopt beds. Riverbank warriors removed honeysuckle in Harrison Park. Meeting scheduled in June to discuss annual checkup. Discuss 2<sup>nd</sup> Ave. sewer project, honeysuckle removal, entryway. Battelle/Perry Street Park – who gets to make the decisions? City or developer with our input? Not sure they are being upfront with what happened in the purchase of that land. Some \$ set aside with the purchase (\$850k) what does that cover? Entry/plaza off Perry St. to engage with the neighborhood. Will convene a Perry St. Park committee meeting. ([parks@harrisonwest.org](mailto:parks@harrisonwest.org)). Please clean up after your dog.
