# Know your neighbor; know your neighborhood!

### Report suspicious persons and activities

**REPORTING SUSPICIOUS ACTIVITIES** requires raising your awareness level; that is, knowing what is normal or what is out of place—or having a suspicion or a gut feeling that something is wrong. The goal is to reduce criminal opportunities by reporting your suspicions.

This requires that you be both *observant* and *aware* of persons and events in your neighborhoods, work locations—and as you travel through Columbus. You must also overcome any reluctance you might have in reporting these observations to the police.

Following is a comprehensive list of activities which should be reported.

- Anyone engaged in forced entry into a house, garage or vehicle.
- Anyone running from a house.
- Anyone around a house checking doors or windows, or anyone who appears to be attempting to hide from view.
- Anyone loitering in the neighborhood, appears out of place or are unknown to you.
- Anyone with a weapon.
- Any unusual noise, regardless of the time of day; for example, a scream, breaking glass, loud crashing sound, prying or any audible alarm.
- Anyone carrying what might be loot; for example: radios, TVs, stereo equipment, large sacks, bags or pillowcases which appear to be full might be indicative of criminal activity.
- Any suspicious vehicles parked on the street or in your neighbor's driveway.
- A solicitor who does not appear to have a valid reason for coming to your door, seems overly aggressive or forceful, appears hesitant, does a lot of unnecessary looking around, or asks unusual questions concerning you or your neighbors' daily schedule or habits.

### When reporting information remember the following...

- **GET AN ACCURATE DESCRIPTION** of the individuals and vehicles involved, including license plate numbers.
- Remain as calm as possible and give the dispatcher the details of your observations; the dispatcher relays the information to patrol cars that are *en route* to investigate.
- Relay the exact location where the activity is occurring. It would be helpful if you provided your name, address and phone number in case

some of the information needs later clarification. However, this is not absolutely required.

• You can remain anonymous but be advised that this will limit the actions an officer can take. The important factor is to call anytime—day or night. You may be preventing a crime in progress or helping in the apprehension of a criminal.

### Personal crime safety prevention tips

**BE STREET WISE AND SAFE.** Stand tall and walk confidently. Watch where you are going and what is happening around you.

Stick to well-lighted and busy streets. Walk with friends. Avoid shortcuts through a dark alley or a deserted street.

If harassed from a vehicle, walk quickly or run in the opposite direction to safety. If you are really scared, scream!

Never hitchhike; accept rides only from people you know and trust.

Do not 'flash' your cash; carry only money you need for the day. Always have emergency change for a telephone call; plan on your cell phone not working when you really need it.

Know your neighborhood! What hours are stores and restaurants open? Where are police and fire stations, libraries and schools? You will need them in an emergency.

If you go out for a late snack or a midnight movie, take a friend. Do not go alone. Most assaults happen to a lone victim.

Let someone know where you are going and when you will come back. Call if you are going to be late.

If you are driving, park your vehicle in a well-lighted location and lock it when you leave. Check for uninvited passengers in the back seat or on the floor before you get inside the vehicle.

Have your keys in hand when approaching your vehicle. Do not wait until you get to the vehicle to look for your keys.

Alter your routine. Change daily patterns and if possible, take different routes to work or to school. Park in different locations that are well lit.

When jogging or bicycling:

- Go with a friend and take a familiar and well-traveled route.
- Do not jog or bike at night.
- Refrain from using your stereo head-phones.

It is safer to remain alert to what is around and behind you.

### If you are a victim of crime...

**OF COURSE IT WILL BE HARD**, but try not to panic if someone attacks you. Remember the attacker carefully so you can give a description. Remember key things as best as you can like approximate age, gender, race, complexion, body build, clothing, approximate height and weight, hair, eyes, or unusual features.

If a gang harasses you, go to an open store, gas station, firehouse or any place where people are present; then call 911. If the attacker has a weapon and only wants your money or possessions, **do not fight**. Your life is more important!

**Reminder...** Report all crime to law enforcement. For life-threatening emergencies call 911. For non-emergencies call 645-4545.

## Giant Eagle plans new store

# Public invited to Statehouse lighting ceremony, Holiday Festival

**DOWNTOWN**—Governor and First Lady Strickland will officially kick off the holiday season on Capitol Square with the lighting of two Ohio Statehouse Holiday Trees on December 1, 2008.

The lighting is the culmination of a short ceremony which begins at 5:30 p.m. on the West steps (High Street) of the Ohio Statehouse.

This is the 93rd annual Ohio Statehouse Holiday Tree Lighting event held on Capitol Square.

The short tree lighting ceremony will include music provided by the Con Brio Children's Choir from Westerville and the Salvation Army Band. Governor and Mrs. Strickland will welcome visitors and usher

in the holiday season by flipping the switch to light the two official Statehouse holiday trees. Both live trees are planted on the West Plaza.

Governor Strickland will then command the firing of a civil war era cannon which will signal special holiday lighting of the Capitol Square complex and surrounding buildings. The cannon will be fired by members of the 1st Ohio Statehouse Light Artillery, Battery A.

The ceremony will be followed by a free holiday festival in the Rotunda and Atrium. The festival will include refreshments and performances by community choirs and the Chapel Brass of the Salvation Army.

Other program elements will include a Lego Club model train display, a Garden Railroad Club model train display, a Santa

and Mrs. Claus photo station, a finger printing I.D. station, live animals, Civil War re-enactors, various community mascots and much more.

The event is free and open to the public. The entire program will be held inside the Statehouse if the weather is inclement.

In-kind event sponsors include Kroger, Starbucks and Costco.

## The Trees

The trees are both living 28 foot Blue Spruces planted on the Northwest and Southwest corners of the Ohio Statehouse West Plaza in 1996. Each tree is decorated with more than 15,000 white mini and C7 lights and 285 ornaments consisting of 10-inch finials and 8-1/2 inch stars in red, gold, and silver and 5-1/2 inch and 8-inch ball ornaments in red, gold, blue and silver. Each tree is topped with a star.

# Clearing the 'tree-way'

One of the great things about Harrison West is how many neighbors you can meet just sitting on your front porch. It seems as if everyone in our neighborhood goes for nightly or weekly walks along our tree-lined streets.

The other really nice benefit to having so many amblers in Harrison West is that they serve as an informal neighborhood watch, noticing when something is amiss at Mary's place, corralling Terry's stray pooch who slipped under the fence, and just generally keeping an eye on each other.

I walk my dog, Maus, at least once a day, and I love to see what my friends and neighbors are doing with their lawns and gardens—when I'm not whacked in the face by low-hanging branches, that is. I tend not to watch where I'm going.

I've got three trees in my tree lawn and have just added three more trees to my yard. When they mature, I plan to keep them pruned up; I want to see more neighbors passing by my house, not avoiding my corner and a poke in the eye.

I wasn't sure, though, that I was allowed to prune street trees — the trees the city has planted between the sidewalks and streets — so I called Jack Low in Columbus' Department of Recreation and Parks, Forestry Section and got some good advice, and the city's rules, on trimming my trees.

Jack told me that trees overhanging sidewalks should be pruned up to eight feet — and up to 13.5 feet over streets.

Residents should prune trees that are on their property, but the Forestry Section is responsible for trimming street trees.

If you have street trees that you'd like pruned or that are impeding your sidewalk, and the sharp eyes of your neighbors, Jack advises you to call his office at 645-6640 and put in a request to have them trimmed. You can even request that your entire street be pruned if you know there are a number of street trees that need attention.

The Forestry Section is small, though, and the demands on it are large; it could take six months or a year before the department can respond to your request. Jack offers an alternative, though.

If you would like a permit to prune your own street trees, you can call his office and request a permit. The Forestry Section will send out an arborist to look at the tree you want to prune, give you advice on where and

how to prune, and issue you a free permit on the spot.

If you've got a tree that appears to be heaving or destroying your sidewalk, you should call Jack's office, too. An arborist will come out to determine what to do about the adjacent tree. Unfortunately, the repair to the sidewalk is up to you.

Jack also recommends that you prune after a tree has dropped its leaves. It's easier to see what you need to do without the foliage in the way. He recommends pruning low branches and branches that cross.


