Officer Residency Status

The HWS Treasurer, Ms. Borlaza and her husband Mr. Gil Borlaza have recently moved their residence out of Harrison West, while at the same time buying a rental property in the neighborhood. At issue is that the Harrison West Society Constitution and By-Laws currently state: "All officers must be residents of Harrison West." Due to the vague nature of the By-Law regarding compliance at the time of election or for full term, the Society placed a motion to interpret the By-Laws as "All officers must be residents of Harrison West for the full term of office". The Motion to interpret the By-Laws failed leaving the vague nature as is.

I, as the President of the Society with consult from my fellow officers, executive committee, and advisors have made the following ruling: The Society will honor the residency status at the time of election and allow the treasurer to serve out the remainder of the term in good standing. Basis for the ruling are as follows:

- Resident at the time of election with no prior intentions of moving outside the neighborhood.
- Registered CPA, devoted member of our Society, and wishes to continue her dedication to our neighborhood.
- Voting member based on neighborhood property ownership.
- Precedence was established when the 2001-2002 President of the Society lived the majority of the term outside the neighborhood, no call for resignation was made.
- Corrections or clarifications to the By-Laws should be handled by committee, and then properly implemented under the guidelines of our Constitution.

HARRISON WEST SOCIETY MINUTES

July 19, 2006

The regular monthly meeting of the Harrison West Society was held on Wednesday, July 19, 2006, at 7:00 p.m., at the First Brethren Church, 473 W. Third Avenue. President Mr. Rob Harris, Vice President Ms. Mary Funk and Secretary Ms. Barbara Kobbie were present. Treasurer Ms. Becky Borlaza was not in attendance.

Mr. Rob Harris welcomed the attendees and introductions were made. A quorum of more than eight was reached; twenty-five were present. The minutes of the last meeting were approved. Mr. Harris said that Harrison West Society balance is currently \$8,267.04 and inquired if there were any outstanding expenses. None were reported.

Mr. Harris reported that Tom McClain Vice President of Corporate Communications at Battelle and their liaison to Harrison West, is retiring. Mr. Harris indicated that a letter should be sent stating the Harrison West Society's appreciation of his years of service and dedication.

Mr. Craig Copeland Traffic Committee Chair said that he has worked with Mr. McClain. Mr. Copeland further outlined Mr. McClain's accomplishments such as the Fifth and Perry green space, the Third Avenue Bridge and the tree plantings. Mr. Copeland moved to adopt a motion to send an appreciation letter.

The motion was approved.

Mr. Harris clarifies TIF regarding Harrison Park.

Mr. Tom Maxwell Audit Committee Chair reported that the Audit Report will be published in the newsletter.

Mr. Jerry Colvin Budget and Finance Committee Chair reported that his newly formed committee has not had a meeting yet. Mr. Colvin was considering a "rainy day" fund.

Pastor Morris Civic Relations and Conservation District Committee Chair reported that light rail and street cars were discussed at the Counsel of Historic Neighborhoods.

Ms. Mary Funk said that the city of Columbus was in favor of street cars.

Ms. Stephanie Celebrezze Communications Committee Chair was not in attendance; however Mr. Gil Borlaza a communications committee member reported that the committee was in the process of preparing a Harrison West Society brochure. Time Warner is donating the cost of the printing of the brochure. In addition, the communications committee is also considering a Harrison West Society business discount card.

Mr. Chris Ruder Constitution and By-Laws Committee Chair reported that he is continuing to redraft the By-Laws for review by the Executive Committee. Mr. Ruder is pursuing the current Harrison West boundaries as well as researching the issue of previous By-Law adoption, due to a lack of proper documentation; it is unclear which By-Laws are currently in effect.

Mr. Rick Kobbie Elections Committee Chair reported there is an election of officer issue.

Mr. Harris then described the issue in his report.

Mr. Harris reported that HWS Treasurer, Ms. Borlaza and her husband Mr. Gil Borlaza plan to purchase a rental property in Harrison West and move their residence out of Harrison West. At issue is that the Harrison West Society constitution and By-Laws currently state:

"All officers must be residents of Harrison West."

Mr. Harris stated that during Mr. Keith Dimoff presidency (2001 - 2002), he lived the majority of time in another neighborhood. No one opposed or asked for his resignation.

Mr. Harris then opened the floor for discussion regarding this matter.

At issue:

- If an officer is elected, but then moves during their term, are they able to finish their term of office?
- Article V, 3 does not make clear if the officer must be a resident when elected or for the full term of office.
- Are there extenuating circumstances?

A motion was placed before the Society by Steven Cross:
Harrison West Society Constitution and By Laws states:

Article V. Officers

3. All officers must be residents of Harrison West. Interpreted as..."All officers must be residents of Harrison West for the full term of office."

- In agreement with this statement - 8
- Disagree with this statement - 10

Motion fails.

Mr. Harris said that the Executive committee will discuss the issue further and he will take it under advisement.

Mr. Tony Celebrezze Membership Chair was not in attendance

Ms. Debbie Colvin Parks Committee Co-Chair reported:

Mr. Paul Walters of Metropolis has been contacted about scheduling cleaning and polishing of the Side by Side sculptures for late September-October.

Alpha State is sponsoring a fashion show highlighting fashions by Greenweavers Organics of Dayton, Ohio. The show is July 30 from 1-6 p.m. at Alpha State's studio at Third and Michigan. See the July newsletter for more information.

Tree removal and pruning has been done by the City at the Harrison West Park.

Mr. Bob Mangia Parks Committee Co-Chair (not in attendance) is reviewing plans of irrigation winterization before proceeding with process of receiving quotes for work.

The water line was punctured at Side by Side park, so there is currently no water service at the Park. And there is still no water service at the Harrison West Park - as it is connected to the construction of the traffic islands.

- Mr. Brad Westall, Columbus Recreation and Parks Department, is asking for support with his project. He is applying for Transportation Enhancement Funds to build a bike way connection to the Olentangy Trail, along Goodale Boulevard.

The Oriental place next to Spinelli's Deli in the Thurber Center finally opened. They had three great days during which they were overwhelmed with patrons. Last Friday they closed for the day to boost their kitchen capacity. If you eat Oriental food, don't waste a minute getting there.

Neighbor Jean Godby and I stopped by last Thursday for a catching-up dinner. More than 100 people came, ate, and went in the hour we were there.

Oodles noodles and dumpling bar is just what this neighborhood needs. The food is good, creative, inexpensive -- and when they get the kitchen up to speed -- will be fast.

The Lemongrass dumplings are excellent; crispy, stuffed with chicken and veggies, and exotic tasting.

The pork potstickers are terrific! I could make a meal of these, and at \$3.50 for 5, can afford to do so.

The spicy Thai peanut noodle was really good, but you could ask them to up the heat a bit.

If you're eating light, get a mixer rice bowl with fresh Asian veggies with a choice of chicken, beef, shrimp, or tofu.

In the exotic salad line, try the Vietnamese cold noodles -- greens, vermicelli, peanuts, Thai herbs, citrus dressing.
