## **NOVEMBER MEETING MINUTES**

The meeting was called to order at 7:00 PM with a quorum of voting members present (14). There were two new members in attendance: Rob McCarthy and Leslie Siegel.

#### **Routine Business**

Minutes Dick Montgomery moved to approve the minutes of the October meeting as posted in the November newsletter. Seconded. PASSED unanimously.

Treasurer's Report We have \$3.612.06 in checking, \$2,517.26 in savings, and \$2,621.25 in the CD.

Committee Reports None.

Holiday Party The President raised the question of where we should have the Holiday Party. A recommendation from the floor was given that we have it at Harrison Park Community Center since this is our new home and it is in Harrison West. A question was raised if we would need a liquor permit. Joe George stated that since this was limited to HWS members and their guest then we do not need a liquor license. Pastor Morris made a motion to send a thank you letter to Victorian Midnight Cafe, cancel the December meeting, have the Holiday Party at Harrison Park and allocate up to \$400 for the party, if needed. Seconded. PASSED unanimously.

Membership Mailing Chris Ruder presented a draft of the annual membership drive letter for review. Minor corrections were suggested and approved. We have 99 new members in 2007 of which 86 are from Harrison Park, Jacob Sukosd made a motion to make the corrections and allocate up to \$200 for mailing as needed. Seconded. PASSED unanimously.

Wheeler Dog Park The city is in the process of looking at putting a dog park in Wheeler Park. Jim Slone provided a summary of the meeting that was held the Pastor Morris announced that his previous night with those who live next to Wheeler Park and the surrounding neighborhoods. See the article in this issue of Harrison West News for details

on the dog park. Pastor Morris brought up that we need to be mindful that kids need to be thought of also. Greg Maynard (from Friends of Goodale Park) noted that there is a kids place in Goodale Park and the Friends of Goodale Park are in the process of improving that area. Jim made a motion that we send a letter to the City Parks and Recreation department in support of the dog park and to ask Rob Harris to lead the effort to work with Bob Mangia and the city on behalf of HWS. Seconded. PASSED unanimously. Rob accepted the position.

**Demolition of the Compton Properties** 

There is a possibility that the Compton Property will be demolished earlier that originally planned. It was generally agreed that HWS supported the early demolition although no motion was made to that effect.

#### **New Business**

Boundaries There was discussion about what are boundaries are and what they should be. The TIF exceeds our eastern boundary as stated in the By Laws. There was a discussion on extending our boundaries to cover the extend to Neil Ave then south to Goodale Ave. west to CSX railroad, north to 3rd Ave., East to Olentangy River Road, and north to 5th Ave where it will meet the boundary as stated in our By Laws. Joe George made a motion to amend the By Laws Article I(b) from the current boundaries to the proposed boundaries and up to \$100 for the mailing to the membership to announce the change. Seconded. PASSED unanimously. The boundary vote will be held at our January meeting.

#### GOING GREEN TWEAKING TRADITION

Are you gifting green this holiday season?

When list making starts, it's hard to stop ; you'll think of lots more to add...

- *The Lorax* by Dr. Seuss; *Animal, Vegetable, Miracle* by Barbara Kingsolver
- for anyone you love:
- a cloth tote or bag, net bag, canvas carrier
- something made locally
- something made by you of recycled materials
- something you already have but no longer need
- something you baked
- Fair Trade coffee, chocolate, crafts
- your time
- a monthly bus pass
- a service, like sidewalk-shoveling, babysitting

#### Ten Things You Should Never Buy Again

1. Styrofoam cups

Styrofoam is forever. It's not biodegradable.

*Best option*: Invest in some reusable mugs that you can take with you.

2. Paper towels

Paper towels waste forest resources, landfill space, and your money.

*Best option:* Buy dishtowels or rags to wash and reuse.

3. Bleached coffee filters

Dioxins, chemicals formed during the chlorine bleaching process, contaminate groundwater and air and are linked to cancer in humans and animals.

Best Option: Use reusable filters.

4. Over-packaged foods and other products

Excess packaging wastes resources and costs you much more. Around 33% of trash in the average American house-hold comes from packaging.



Best Option: Buy in bulk and use your own containers when shopping. 5. Teak and mahogany Every year, 27 mil-

lion acres of tropical rainforest (an area the size of Ohio) are destroyed. Rainforests cover 6% of Earth's surface and are home to over half of the world's wild plant, animal, and insect species. The Amazon rainforest produces 40 percent of the world's oxygen.

*Best Option:* Reuse wood, and buy furniture and other products made from used or salvaged wood.

6. Chemical pesticides and herbicides

American households use 80 million pounds of pesticides each year. The EPA found at least one pesticide in almost every water and fish sample from streams and in more than onehalf of shallow wells sampled in agricultural and urban areas. These chemicals pose threats to animals and people, especially children.

*Best Option:* Plant native plants and practice integrated pest management. Plant flowers and herbs that act as natural pesticides.

7. Conventional household cleaners

Household products can contain hazardous ingredients such as organic solvents and petroleum-based chemicals that can release volatile organic compounds (VOCs) into your indoor environment, positing a particular danger for children. The average American household has three to ten of hazardous matter in the home.

*Best Option*: Try making your own green cleaner using vinegar, water, and castile soap.

8. Higher octane gas than you need

Only one car in ten manufactured since 1982 requires high-octane gasoline. High-octane gas releases more hazardous pollutants into the air, and may be bad for your car.

*Best option:* Make your next car purchase a hybrid. Or ditch the car and take public transportation, ride a bike, or walk.

9. Toys made with PVC plastic

70% of PVC is used in construction, but it is also found in everyday plastics, including some children's toys. Vinyl chloride, the chemical used to make PVC, is a known human carcinogen. Also, additives, such as lead and cadmium, are sometimes added to PVC to keep it from breaking down; these additives can be particularly dangerous in children's toys. PVC is also the least recycled plastic.

*Best option:* Take action to tell manufacturers to stop using PVC plastics, especially in children's toys.

10. Plastic forks and spoons

Disposable plastic utensils are not biodegradable and not recyclable in most areas.

*Best option:* Carry your own utensils and food containers.



#### SWACO OPENS PERMANENT HOUSEHOLD HAZARDOUS WAST SITE

Residents of Franklin County are now able to dispose of their Household Hazardous Waste (HHW) at a centrally located permanent location located at the corner of East 8<sup>th</sup> Ave. And Essex Ave. (1249 Essex Ave to be exact). Essex is a few blocks west of the 11<sup>th</sup> Ave. Exit of I-71. The center is available for drop off on Wednesdays from 2 - 9 p.m. and Thursdays from 9 a.m. To 6 p.m.

"We are very excited to provide this additional service to residents and our partner communities," says SWACO Executive Director Ron Mills. "While SWACO plans to continue our warmer weather mobile HHW collections, this location will provide a a year round opportunity so residents do not have to wait for SWACO to come to them."

Residents may bring their old gasoline, lighter fluid, thinners, pool chemicals, paint, etc. to the 1249 Essex. "We know that residents appreciate the availability of our environmentally sound methods of disposal," adds Mills. In 2007, SWACO's mobile HHW drives netted 1.2-million pounds of material


from 12,500 households. That is an increase of about 200,000 pounds from 2006. A complete list of acceptable materials is found at www.swaco.org


Director Mills emphasizes that HHW's should be brought to 1249 Essex only during the posted hours. Dropping off materials during other times will be considered illegal dumping. "We are happy to provide this facility and additional service to residents, but as with all SWACO operations we are ever mindful of our neighbors. We hope residents will help us keep the area clean by using the facility only during the posted hours."

From Harrison West go east on 5<sup>th</sup> Ave. Turn north (left) on to Corrugated Way. Around the curve, this becomes East 8<sup>th</sup> Ave. East 8<sup>th</sup> Ave. dead-

ends into Essex Ave. Turn south (right) to get to SWACO.

Please check their website for the correct way to disposal of items before you drop them off so that you can be assured that they will accepted by SWACO.
