Minutes of the Meeting of the Harrison **West Society** Held on 17th February 1994 at the First Brethren Church.

Call to Order. The meeting was called to order at 7:00 PM with the President, Glen Cook, in the Chair. The meeting had been delayed by one week because of the serious weather the preceding Thursday.

Minutes of the Last Meeting. The Minutes of the meeting of 11th November 1993 as published in the Harrison West Newsletter were approved as published.

Treasurer's Report. The treasurer, Chris Hershberger, reported that the Society had a balance of \$626.71. Advertising revenue was beginning to come in for the Newsletter and there had been no bills from the attorney since August. A bill for \$125.64 for printing the Newsletter was presented and a motion to pay it passed.

New Business. Jay Moore, the Scoutmaster of local Boy Scout Troop 29, discussed cashless projects that his troop had been undertaking in the area. The troop has been doing yard and garden work for some of the less able people in the Short North area. The new requirement to use biodegradable leaf bags for garden waste will cause financial problems and the troop is looking for other ways to deal with any waste collected. Mr. Moore is looking at creating a communal composting site somewhere in the area, for example on the land on the NW side of Perry and 3rd. Mr. Moore stated that Batelle, the owner of the land, was willing to consider the request if a lead sponsor could be found.

The boys are young and need adult supervision and so would do most of the work over a few weekends in the spring and the fall when adult supervision was available. The Martha Walker Garden Club was willing to offer technical advice but not to act as sponsors. It was agreed that Harrison West

Society will discuss a possible compost project with Battelle. Adult volunteers will be needed and should contact Jay Moore at 299-0113.

It was reported that trucks delivering to Morettis are cutting through the vacant lot behind the plant from Michigan Avenue. Residents are requested to take photographs and to identify trucks and the trucking companies responsible. The Society will contact thetrucking companies. Truckers are generally responsible for any damage that they do to sidewalks or buildings and they must reminded of this liability. Efforts to work with City Council and especially the City Attorney should be redoubled.

The Society will ask that a spokesman for the City or Municipal Power come to the May meeting of the Society to explain the plan to install 60 ft. high utility poles carrying 130,000 volt power lines on Michigan and 5th Avenues.

Two nominations for Officers of the Society were received: Craig Copeland for President and John Cowan as Vice-President.

It was suggested, and the President approved, that the closing for nominations and for the elections to be put back one month to March and April respectively.

There was a brief discussion about plans for the planting on the corner of 3rd and Perry. Some minor changes will be made in the annuals planted but the base of hardy native perennial plants will remain unchanged. The possibility of setting up a program to trim the lower branches of some of the younger trees in the area was discussed. It was pointed out that these branches will stay at their present heights and cause problems to traffic.

Adjournment. There being no further business, the meeting was adjourned at 7:45 p.m.
