Humko Redevelopment **News Better** and Better for **Harrison West**

Developer Mark Wagenbrenner and **Architect Rob Harris** brought two surprises to the last Harrison West meeting when they presented the revised site plans for the redevelopment of the AC Humko site.

The revised plans, which may be viewed at our website at harrisonwest.org, include an enlarged park along the river and the incorporation of the Outlands property into the development.

Mark, Rob and a City representative presented a plan for two tax increment financing (TIFs) related to the Humko site. The TIFs will generate funds over a 30-year period to help pay for infrastructure improvements to the site and for improvements and land acquisition for the new riverside park and the neighborhood. A new Harrison West Park Committee/Steering Committee is being formed to work with the City and the developer on the new park and to advise on how the TIF funds will be spent.


At November's meeting, the Harrison West Society voted to support the TIFs and the revised plan as presented by Rob and Mark.

Neighborhood support of the TIFs is critical to encourage City Counsel to pass them.

Reason #1 to Join the Harrison West Society

With the upcoming Neighborhood TIF, the new development on the former Humko factory, the development of the rundown Outlands property and the Compton property, and the new 5.7 acre park along the Olentangy River, the Harrison West Society is making major decisions on big changes in the neighborhood. The Society will be controlling the TIF funds disbursement for capital improvements for the next 30 years, too. As a Society member you will have a voice in those decisions.

Area Commission Would Be A Strong Voice for Our Neighborhood

Last month we ran an article by Society member Rob Harris on why an Area Commission would be good for Harrison West. So many members had further questions that the Editor decided to run the rest of Rob's material, which describes in detail what an Area Commission does. Please note, an Area Commission is NEITHER an Historic nor a Neighborhood Commission such as exist in Victorian or German Village.

If you need the introductory material, please refer to the November News on harrisonwest.org.

The issue of the Area Commission will be discussed at the January meeting with a presentation from the City.

The functions and duties of an Area Commission are advisory and do not invalidate actions of city council. In general an area commission shall:

- (1) Create plans and policies, which will serve as guidelines for future development of the area;
- (2) Bring the problems and needs of the area to the attention of appropriate government agencies or residents; and
- (3) Recommend solutions or legislation.
- B. Aid and promote communications within the commission area and between it and the rest of the city by means of:
- (1) Regular and special meetings of the commission which are open to the public;
- (2) Public hearings on problems, issues, and proposals affecting the area;
- (3) Public forums and surveys to provide an opportunity for area residents, businesses, and organiza-

tions to state their problems and concerns;

- (4) Soliciting active cooperation of all segments of the area and city, including organizations, institutions, and government;
- (5) Initiating proposals and supporting those introduced by individual citizens or area organizations, which will enhance the quality of life enjoyed by area residents and preserve the unique residential and commercial mix of the area; and
- (6) Promoting and encouraging businesses whose functions, methods of operation, architectural appearance, and locations are consistent with the character and requirements of the area.
- C. Initiate, review and recommend criteria and programs for the preservation, development, and enhancement of the commission area, including, but not limited to, parks, recreational areas, sidewalks, streets and traffic, by means of:
- (1) Reviewing the proposed capital improvements budget and proposing new items and changes relating to the area;
- (2) Making recommendations for restoration and preservation of the historical elements within the area; and
- (3) Receiving and reviewing for recommendation, prior to adoption by governmental bodies, any new or revised comprehensive plan affecting the area.
- D. Recommend priorities for and review government services and operation of the various government departments in the commission area by means of:
- (1) Requesting and receiving from departments or agencies peri-

odic reports concerning governmental services or practices in the area;


- (2) Meeting with administrative heads of any department or agency, or any of their subordinates, to obtain additional information deemed necessary for the commission to fulfill its functions;
- (3) Requesting and receiving from departments or agencies, prior to implementation, full reports on any proposed changes in service or practice in the area, and recommending approval or disapproval of the proposed changes;
- (4) Reviewing and evaluating pending legislation substantially affecting the area prior to its consideration by council; and
- (5) Regularly receiving for review, comment and recommendation from the development regulation division copies of applications and notices of all public hearings related to rezoning, special permits, variances, demolitions, and zoning appeals regarding property located wholly or partially within the area.
- E. Recommend persons from the commission area for nomination to membership on city boards and commissions, which make decisions or recommendations affecting the commission area. (Ord. 2654-96 § 1 (part).)




Each applicant for a rezoning, special permit, variance, zoning appeal, or demolition permit shall be notified of the existence of an area commission with advisory jurisdiction concerning the application and shall be advised to contact such commission.


Studio 19 Showing Extra-Edgy Work in December

The bread is a hard, crusty loaf, rather coarse, and delicious. Good for sopping up the last drop of sauce. It comes with three spreads: garlic butter; and almost fruity mix of stewed onions, carrots, olives, peppers, caper grapes, and raisins; and a white bean puree with lemon zest. You won't miss plain butter at

all.

The friend who was playing Eadie Gourmet with me cannot eat fish, so we were unable to sample the roasted clams, the tuna carpaccio, or the evening's special of swordfish.

But we dined very well on gnocchi all forno and eggplant parmesan.

Gnocchi, which can be heavy as a holiday fruitcake, as Basi presents them are delicate, almost ethereal, and complement the earthiness of the wild mushroom bechamel sauce. Yin and Yang on a plate.

The eggplant parmesan was another delicious surprise. The robust slices were coated with cornflour (cornmeal to the rest of us) and cooked so quickly and well that one could feel and taste the cornflour. The slices were firm and meaty, and missing entirely the soggy bitterness so often found in cooked eggplant. The sauce brought a sunny mix of tang and sweet tomato to the dish.

Unfortunately, my guest cannot eat chocolate (!!), either, so we passed on the lovely chocolate

mousse presented on the dessert tray. The lemon cake with ricotta cheese and a lemon pannacotta rounded off our meal very well. The lemon cake was muffin-textured and sweet-tart.

The pannacotta, that lovely Italian milk custard, snuggled with a trio of strawberries macerated in red wine, cinnamon, and sugar under a cloud of real whipped cream.

With the meal we drank a bottle of Banfi Principessa Gavia, at \$26 a reasonable choice.

Basi is not a restaurant for children, as the service is continental in its timing. Prices are more than reasonable, especially considering the quality of the food, the preparation, and the inspired recipes. Parking is impossible, and since it's just a block and a half east of the Big Bear, might as well walk.

I promised our waiter, Rick, that I would mention him. You'll know him -- he's the one with the hair explosion. Don't be put off. He's eaten everything and can talk knowledgeably about it. He's a good waiter, too.

Eadie Gourmet Eats Out at Basi Italia

Everything you've been hearing about the new Basi Italia is true: it's hard to find, there's no parking and little seating, reservations are hard to get, and the food is fantastic.

However, if you are willing to eat early on a weeknight, you just might be able to experience this bit of food heaven before the next millennium (that's 294-7383 and you'll probably need directions).

Everything I tasted was good. In fact, I don't think you could go wrong on anything on the menu. What you look for here, though, is the singular Basi approach to food. Chef/owners John Dornback and Trish Gentile are exploring the sometimes surprising relationships of tastes.

Consider their grilled endive salad, for instance. Endive is bitter lettuce. Who would grill it? Chef Dornback would, and then fill it with almost melting gorgonzola cheese sprinkled with pistachios, and drizzle it with a balsamic vinegar reduction -- burned lettuce topped with pungent cheese and vinegar. Sounds tasty, doesn't it?

It works. It tastes -- well, it wakes up your taste! Somehow the bitter lettuce is mellowed by the grilling, and further mellowed and sweetened by the gorgonzola and pistachios. The final perfection is the anointing with the slightly thick, slightly sweet vinegar. If Dornback thought this one up all by himself, he's an inspiration to all cooks everywhere.
